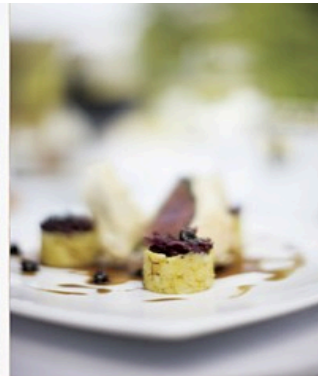
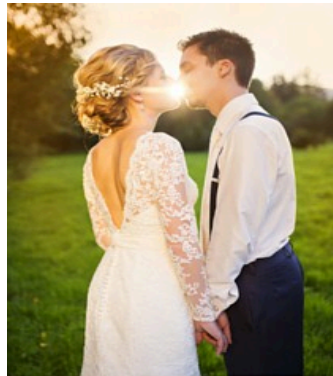

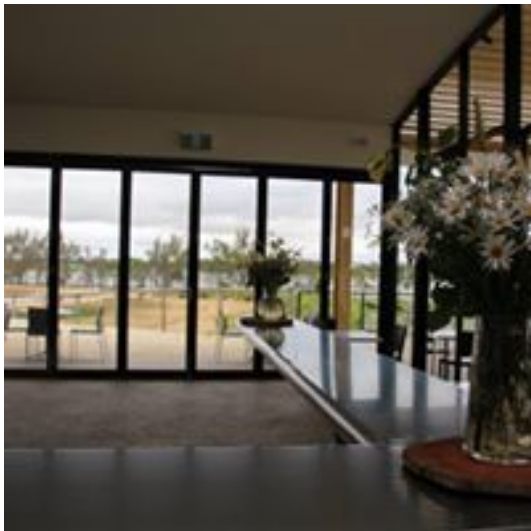
Salt & Pepper calamari on baby cos leaves, julienne vegetables with a hot and sour dressing

What happens next?

Within 10 days of receiving our wedding package we will contact you to arrange a site inspection and meeting that is convenient for you.

Booking with us

A tentative booking will be held for your chosen date for 10 days from meeting date.

Following the meeting you will be issued with a wedding agreement form for signing, this is required to be returned with your deposit. By signing our agreement you acknowledge and accept the terms and conditions listed here.

To book your date a deposit of \$1,000 is required. This deposit is non-refundable or non-transferable.

We also require a \$300 bond.

Cancelations

We understand that sometimes things do not work out as expected and we try to make these changes as easy as possible for both you and us.

We require written notification of the cancellation of your booking.

However the following charges will apply if cancelled within 90 days of your secured date

30-60 days	\$3000 is payable
7-30 days	\$4000 is payable
< 7 days	\$5000 is payable

Prices

Prices are current for the 2017 wedding package and are valid until 1st January 2018.

Payment

Payment in full for your wedding package is required 21 days prior to your wedding.

Payment can be made via bank transfer, cash or credit card; a 1.5% surcharge applies for credit card payments. Cheques will only be accepted upon prior approval.

Menu selection

Your confirmed menu selection is required 21 days prior to your function

Dietary Requirements

All dietary requirements can be catered for

A full list of dietary requirements is required to be supplied 21 days prior to your function

Should unexpected dietary requirements arise on the night a further \$25 charge will apply per guest needing appropriate alternative meals.

Children

Children are most than welcome to attend functions at our venue. However it is the sole responsibility of their legal parent(s) / guardian(s) to ensure they are looked after and supervised throughout the function. Le Penelope's and Kirwan's Bridge Estate hold no responsibility for injury, or damage whilst at our venue.

Function times

Our wedding function package will run for duration of 5 hours. With the reception starting no earlier than 6pm.

Beverages on consumption

We are happy to offer you drinks at bar prices for your function. This option will be discussed in detail with you at our meeting,

Terms & Conditions





Liability

The client(s) signing this agreement does so of sound mind and capability.

The client(s) listed on the signed agreement will be financially responsible for all charges outlined in the agreement.

Loss or damage of personal property

Le Penelope's and Kirwan's Bridge Estate hold no responsibility for personal belongings and damages sustained to them through accident, theft or natural disaster whilst attending our venue.

Loss or damage to our venue

The Client(s) listed on the agreement will be financially responsible for loss of property, damage and repair cost for Kirwan's Bridge Estate property and surrounding grounds caused by guests, contractors or colleagues at any stage of the set up, running and pack down of the function.

Behavior expectations

The Client(s) listed on the agreement take full responsibility for ensuring guest behavior is appropriate throughout the function. Le Penelope's and Kirwan's Bridge Estate will intervene and eject unruly guests where appropriate without liability.

Responsible Service of Alcohol

All Le Penelope's and Kirwan's Bridge Estate staff hold current RSA certificates.

All guests that are under the age of 18 are not allowed to consume alcoholic beverages whilst at our venue. Any guest under the age of 18 or guest found to be supplying an under age persons will be asked to leave immediately without liability.

All guests that appear younger than 18 or around the age of 18 will be asked for Current ID.

Security

Whilst every precaution is taken to ensure security of belongings and equipment before during and after the event, Le Penelope's and Kirwan's Bridge Estate hold no responsibility for loss or damage that occurs out of outside of our immediate control and precautionary measures.

Surcharges

A 10% surcharge is payable on public holidays

Surcharges will apply for minimum numbers and additional options agreed to. Additional charges will be discussed with you at the initial meeting and be clearly stated in your wedding agreement.

Confetti

We encourage you to use sustainable, degradable and recyclable confetti for your wedding ceremony. Additional cleaning charges will apply should your confetti choice cause damage to our venue: i.e. colored confetti staining the flooring. No rice allowed.

Cleaning

Standard cleaning is included with your function. However where out of the ordinary cleaning is required after your function, you the client(s) will be responsible for this additional charge.

Client responsibility

You the Client(s) are responsible for informing all guests, contractors and colleagues of the terms and conditions prior to their attendance at Kirwans Bridge Estate.
